65.01 THROUGH STREETS - STOP. Every driver of a vehicle shall stop, unless a yield is permitted by this chapter, before entering an intersection with the following designated through streets.

(Code of Iowa, Sec. 321.345)

1. Highway 71 through the City.

65.02 STOP REQUIRED. Every driver of a vehicle shall stop in accordance with the following:

(Code of Iowa, Sec. 321.345)

1. Gingles Drive. Vehicles traveling west on Gingles Drive shall stop at Iowa Street.
2. Iowa Street. Vehicles traveling on Iowa Street shall stop at Linden Drive.
3. Hinshaw Street. Vehicles traveling east on Hinshaw Street shall stop at Iowa Street.
4. Forest Park Road. Vehicles traveling east on Forest Park Road shall stop at Iowa Street.
5. Rohr Street. Vehicles traveling on Rohr Street shall stop at Broadway Street.
6. Rohr Street. Vehicles traveling south on Rohr Street shall stop at Bascom Street.
7. Bascom Street. Vehicles traveling east on Bascom Street shall stop at Rohr Street.
8. Oak Street. Vehicles traveling north on Oak Street shall stop at Rohr Street.
9. Allen Avenue. Vehicles traveling south on Allen Avenue shall stop at Dewey Street.
10. Zephyr Drive. Vehicles traveling on Zephyr Drive shall stop at Okoboji Grove Road.

11. Lincoln Street. Vehicles traveling on Lincoln Street shall stop at Zephyr Drive.
12. Monument Drive. Vehicles traveling on Monument Drive shall stop at Lincoln Street.
13. Monument Drive. Vehicles traveling on Monument Drive shall stop at Okoboji Grove Road.
14. Elm Street. Vehicles traveling east on Elm Street shall stop at Zephyr Drive.
15. Pillsbury Point. Vehicles traveling east on Pillsbury Point shall stop at Monument Drive.
16. Linden Drive. Vehicles traveling on Linden Drive shall stop at Iowa Street.
17. Allen Avenue. Vehicles traveling on Allen Avenue shall stop at Broadway Street.
18. Monument Drive. Vehicles traveling south on Monument Drive shall stop at Benit Drive.
19. South Emerald Hills. Vehicles traveling south from South Emerald Hills shall stop at 202nd Street.
20. Dam Road. Vehicles traveling on Dam Road shall stop at West Broadway Street.
21. Helms Drive. Vehicles traveling west on Helms Drive shall stop at Dam Road.
22. Emerald Meadows Drive. Vehicles traveling on Emerald Meadows Drive shall stop at Dam Road.
23. Minnewashta Beach Road. Vehicles traveling on Minnewashta Beach Road shall stop at Dam Road.
24. Sunshine Run. Vehicles traveling north on Sunshine Run shall stop at Rohr Street.
25. Sunshine Run. Vehicles traveling east on Sunshine Run shall stop at 240th Street.
26. Mallard Creek Drive. Vehicles traveling east on Mallard Creek Drive shall stop at 240th Avenue.
27. Mook Lane. Vehicles traveling on Mook Lane shall stop at Linden Drive.

28. Park Place. Vehicles traveling on Park Place shall stop at West Broadway Street.
29. Fehrway Drive. Vehicles traveling south on Fehrway Drive shall stop at Rohr Street.
30. Zephyr Drive. Vehicles traveling south on Zephyr Drive shall stop at Lincoln Avenue.
31. Lincoln Avenue. Vehicles traveling west on Lincoln Avenue shall stop at Okoboji Grove Road.
32. West Okoboji Road. Vehicles traveling east on West Okoboji Road shall stop at Okoboji Grove Road.
33. Emerald Pines Drive. Vehicles traveling south on Emerald Pines Drive shall stop at 202nd Street. *(Ord. 04-09 – Feb. 05 Supp.)*
34. Carita Street at the intersection of Lakeshore Drive.
35. Katrina Street at the intersection of Lakeshore Drive. *(#34 and 35 Added by Ord. 10-5 – Oct. 10 Supp.)*
36. Emerald Drive before Benit Drive. Vehicles traveling north on the west leg of Emerald Drive shall stop at Benit Drive. *(Ord. 14-01 – Jul. 14 Supp.)*
37. Blue Heron Road. Vehicles traveling west on Blue Heron Road shall stop at Sunshine Run.
38. Goose Bay Trail. Vehicles traveling west on Goose Bay Trail shall stop at Sunshine Run.
39. Mallard Creek Drive. Vehicles traveling southwest on Mallard Creek Drive shall stop at Sunshine Run.
40. Wood Duck Road. Vehicles traveling south on Wood Duck Road shall stop at 202nd Street.
41. Wood Duck Road. Vehicles traveling north on Wood Duck Road shall stop at Mallard Creek Drive.
42. Lake View Drive. Vehicles traveling south on Lake View Drive shall stop at Mallard Creek Drive.
43. Goose Bay Trail. Vehicles traveling northeast on Goose Bay Trail shall stop at Lake View Drive. *(Subsections 37-43 – Ord. 14-02 – Dec. 14 Supp.)*

65.03 FOUR-WAY STOP INTERSECTIONS. Every driver of a vehicle shall stop before entering the following designated four-way stop intersections:
(Code of Iowa, Sec. 321.345)

65.04 YIELD REQUIRED. Every driver of a vehicle shall yield in accordance with the following:

(Code of Iowa, Sec. 321.345)

1. Carita Street. Vehicles traveling on Carita Street shall yield at Lake Shore Drive.
2. Helms Drive/Dam Road. Vehicles traveling on the east-west intersecting road between Helms Drive and Dam Road (adjacent to north line of McGorrisk's First Addition to Arnolds Park) shall yield. Those traveling east shall yield at Helms Drive; those traveling west shall yield at Dam Road.

65.05 STOP BEFORE CROSSING SIDEWALK. The driver of a vehicle emerging from a private roadway, alley, driveway, or building shall stop such vehicle immediately prior to driving onto the sidewalk/bike trail area and thereafter shall proceed into the sidewalk/bike trail area only when able to do so without danger to pedestrian traffic and shall yield the right-of-way to any vehicular traffic on the street into which the vehicle is entering.

65.06 STOP WHEN TRAFFIC IS OBSTRUCTED. Notwithstanding any traffic control signal indication to proceed, no driver shall enter an intersection or a marked crosswalk unless there is sufficient space on the other side of the intersection or crosswalk to accommodate the vehicle.

65.07 YIELD TO PEDESTRIANS IN CROSSWALKS. Where traffic control signals are not in place or in operation, the driver of a vehicle shall yield the right-of-way, slowing down or stopping, if need be, to yield to a pedestrian crossing the roadway within any marked crosswalk or within any unmarked crosswalk at an intersection.

65.08 OFFICIAL TRAFFIC CONTROLS. Every driver shall observe and comply with the directions provided by official traffic control signals at the following intersections:
