BUDGET TRANSFERS: Linda Nase reported that approximately \$250,000 of excess money is in the General Fund for Fiscal Year End 2019-2020. **RESOLUTION NO. 20-20** APPROVING THE TRANSFER OF NOT TO EXCEED \$250,000 OF EXCESS FUNDS FROM THE GENERAL FUND TO CITY PARK IMPROVEMENTS, WEST BROADWAY AND MONUMENT DRIVE; AND, THE TRANSFER OF NOT TO EXCEED \$45,000 OF EXCESS FUNDS FROM WATER UTILITY TO WATER IMPROVEMENTS. PRAIRIE LANE/ELM DRIVE WATERMAIN PROJECT: Council reviewed an email from Jeff Rose of Jacobson-Westergard & Associates, Inc. stating that ABC Services discovered some lead service lines during the Prairie Lane/Elm Drive Watermain Project. The contractor will do some exploratory digging to see how far the lead services lines extend. The lead service lines will need to be replaced prior to the completion of the project. By City Ordinance, the property owners would be responsible for this cost. Consensus of the Council is to follow-up next month and contact the homeowners to comply with State and Local Code for the health and safety of the community.

ALLIANT ENERGY: Alliant Energy has paid rent for the substation to the City for 2020. The substation has been moved and rather than take a refund for the rent, Alliant is asking for park projects for which they could potentially donate the money towards.
