Motion approving a Transient Merchant Permit for Dorn Produce. Adams/Richter. Ayes: Four. Nays: None. Absent: Christensen.

Motion to approve the Liquor License for Ciao Boji. Watters/Jensen. Ayes: Four. Nays: None. Absent: Christensen.

HWY 71 SIDEWALK PAVERS: Council reviewed documents submitted by the Iowa Department of Transportation detailing the staging plans for the Highway 71 project. In order to attract more bidders, consensus of the Council is to allow work on the sidewalk pavers and driveways Monday through Thursday three weeks into June and resume after August 10. Construction of the sidewalk pavers and driveways may occur between 6:00 a.m. to 9:30 p.m. if needed. Highway 71 will be taken down to two lanes during this time period with no closure.

324 LAKE DRIVE: The sewer main that connects 324 Lake Drive was televised and a large number of tree roots were found in both the main and the service line. Jacobson-Westergard presented the Council with two options to resolve this issue. Council requested that Rose put both options out for bid in July with the work to be done in the fall of 2022. The homeowner will be responsible for the service line from the sewer main to their home.

GENERAL FUND SURPLUS TRANSFERS: **RESOLUTION NO. 16-2022** APPROVING THE TRANSFER OF NOT TO EXCEED \$725,000 OF EXCESS FUNDS FROM THE GENERAL FUND TO: TREE REMOVAL, PARK IMPROVEMENTS – WILDCAT STADIUM, WEST BROADWAY SIDEWALK/WALL REPAIR, AND HIGHWAY 71 IMPROVEMENTS; AND, THE TRANSFER OF NOT TO EXCEED \$150,000 OF EXCESS FUNDS FROM WATER UTILITY TO WATER IMPROVEMENTS.
